Important Notice:

- This application form is SOLELY for MIAFAS processing and administrative matters.
- 2) The introducer shall be required to obtain prior consent from the new applicant in providing their personal information in this form.

MIAFAS Terms & Conditions

- 1) This scheme is applicable to **MIA current students and alumni** only. The new applicant must not be the immediate relative of the introducer. Full-time and part-time employees of MIA and their immediate relatives are not eligible.
- 2) The scheme is strictly for introducing **Malaysian** students to enroll in MIA **full-time Certificate**, **Diploma and Degree programmes**. A Student Introduction Fee with the following rate will be given to the introducer when the new applicant whom he / she recommended has enrolled in MIA and **fully paid the first semester fees**.
 - a) For enrollment to Diploma & Degree Programmes: RM 400 rebate will be given to the introducer for every successful enrolled new applicant who does not receive any forms of scholarship or incentive from MIA
 - b) For enrollment to Diploma & Degree Programmes: RM 200 rebate will be given to the introducer for every successful enrolled new applicant who is a scholarship recipient of MIA. Full scholarship recipients or incentive recipients are not eligible from this rebate.
 - c) For enrolment to Certificate Programme: RM 200 rebate will be given to the introducer for every successful enrolled new applicant.
- 3) This scheme is **NOT applicable** to:
 - a) New applicants who are recommended by MIA's authorised agents; and/or
 - b) New applicants who have participated and awarded scholarship or incentive in competitions (e.g. NAC) or events organized by MIA; and/or
 - c) Progressive students from MIA's Certificate to Diploma programme and/or from Diploma to Degree programme.
- 4) In order for the introducer to be qualified for the Student Introduction Fee, ALL the following criteria must be fulfilled.
 - a) The MIAFAS Form must be submitted with the new applicant's Admission Application Form and sent to MIA Registry **ONE (1) week** before the commencement of new intake.
 - b) The personal information provided in the MIAFAS Form must match with the personal information declared by the new applicant. MIA relies on the introducers to ensure that the personal information in this form is correct.
 - c) The new applicant MUST NOT receive full scholarships or any form of incentive awarded by MIA or any other scholarship awarded by third parties that are associated with MIA.
 - d) The new applicant has accepted MIA's offer and fully paid the first semester fees.
 - e) In the event of a new applicant being introduced by more than one Introducer, MIA will only consider the first received and endorsed introducer's form.
 - f) Should there be any discrepancies of claim, MIA reserves the right to make the final decision.
- 5) Redeem procedures
 - a) Subject to the approval of MIA's management, the Student Introduction Fee will be issued to the introducer two (2) months after the official commencement date of new intake.
 - b) The Student Introduction Fee will offset the introducer's next semester fees. In the event the introducer has fully settled his / her semester fees, it will be issued by cheque as per the introducer's name.
 - c) MIA reserves the right to retain the Student Introduction Fee and use it to offset any outstanding fees of the introducer.
- 6) MIA reserves the right to refuse the payment for Student Introduction Fee if any of the stated terms and conditions are not fulfilled, and if:
 - the personal information provided in the MIAFAS Form does not match with the personal information declared by the applicant (inclusive of unintentional mistake made by the introducer).
 - b) the new applicant has withdrawn his / her study within the first two months upon commencement of the stipulated intake.
- 7) MIA reserves the right to cancel or alter the MIAFAS terms and conditions without prior notice.
- 8) The above terms and conditions will be effective from 1 February 2022.
